The items will be handed over to the highest bidder on "as is and where is" basis. The highest bidder will have to deposit the full amount at the completion of bid process in the Vidyalaya on the same day. After depositing the amount, the bidder should take away the condemned articles.

1. The Bidder must deposit the security amount of Rs.1000/- by crossed cheque/DD/RTGS/Cash in favour of Principal, KV No 2 AFS Adampur before participating in the bidding process.
2. The bidder shall abide by the rules to be declared at the time of auctions.
3. Reserve price will be revealed only at the time of auction.
4. The highest bidder/purchaser will have to remove the condemned material on the same day at their own cost.
5. Public Auction can be cancelled/Postponed due to unavoidable circumstances.
